As per the University mandatory requirements, the college should provide 1,000 sq.ft built-up space and establish adequate Internet connectivity for the smooth conduct of the on line examinations for the academic year 2009-10

Under no circumstance fresh admission be made in the above course(s) for the academic year 2010-11, until and unless the continuation of provisional affiliation is obtained from the University.

As per the AICTE Notification, the Colleges should not collect any excess fees and also they should return all the original certificates to the discontinued students failing which the University will take stringent action on the complaints received. An undertaking letter to this effect should also be submitted by the colleges.

The Management should submit a duly signed undertaking on a Rs.20/ non-judicial stamp paper to the Registrar, Anna University, Coimbatore 641 047, within 15 days from the date of receipt of this letter to the effect that the conditions specified above will be fulfilled.

Note: If at any point of time during an inspection or surprise inspection it is found that the norms and standards prescribed are not maintained by the college the provisional affiliation granted above will be withdrawn without any notice.
